



## 112 年股東會投票紀錄與其他資訊

#### 一、投票相關活動

1、代理研究和代理投票服務

為了協助投票決策,我們設有內部流程並且視情況使用代理顧問。 自 111 年起,本公司 採用 ISS 國際投票顧問機構 (Proxy Advisor)服務以提高投票決策之深度及效率。ISS 的 團隊會審查上市櫃公司所發布的股東會議事手冊,通過全球通用的內部政策並納入各地 的法規規範,來制定投票建議。倘若被投資公司在公司治理、盡職治理、風險管理及受 託人義務等有重大缺失,ISS 會建議反對有關董監事或委員會成員連任。本公司投資團 隊針對 ISS 建議反對的部份,分析其反對之原因和邏輯,決定是否採用其建議。代理顧 問的投票政策和指引,包含其所有的更動,將定期審視。

代理投票提案可能會導致客戶利益與瀚亞投資以及其員工利益之間的衝突。我們採取的步驟必須明確,需證明這些步驟最終導到投票代理的決定時,是基於客戶的最佳權益。

- 本公司指派股東會出席與投票之門檻,係依金管證投字第 1050015817 號令規定辦理, 僅在符合下表條件之情形下,得不指派人員出席股東會行使表決權:
  - 本公司所經理之任一信託基金持有公開發行公司股份均未達三十萬股,且全部信託 基金合計持有股份未達一百萬股時。
  - 本公司所經理之任一信託基金持有採行電子投票制度之公開發行公司股份均未達該 公司已發行股份總數萬分之一,且全部信託基金合計持有股份未達萬分之三。
- 本公司行使投票表決權得依股東會通知書所載,以書面或電子方式為之。採電子投票者 應採電子投票方式行使表決權。

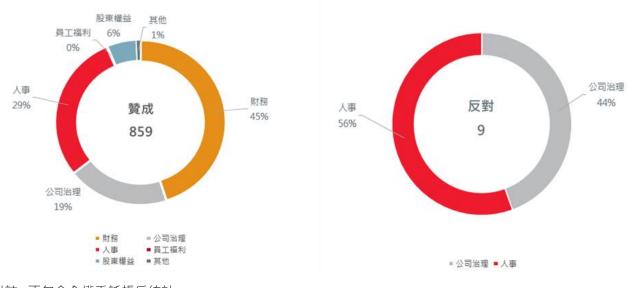
