



# 113 年股東會投票紀錄與其他資訊

## 一、 投票政策與投票活動揭露

本公司在國內上市上櫃投票政策上,充分履行對客戶(包括受益憑證持有人及/或全權委託投 資客戶)的受託責任,代表客戶在股東會議上行使投票權,並遵循應本於客戶之最大利益為 原則,且所有共同基金與全權委託帳戶針對單一個股之股東會議案表決方向應一致。

台灣實務作業如下:

- 1. 非重大議題:基於尊重公司專業經營的角度,原則上同意被投資公司的議案。
- 重大議題:由負責研究同仁,提具分析意見,必要時直接與被投資公司之董事會或管理 階層進行溝通,以作為投票的參考依據。相關重大議題如下所述:
  - (1) 董監事(含獨立董事)之改選、補選、增補:針對董監人選,其適格性或人數等條件,分析說明是否有疑義。
  - (2) 辦理增資(現金增資、私募、CB、ECB...)、發行限制型員工認股權:分析評估對公司營運、財務面與策略面之影響。
  - (3) 減資(含彌補虧損):分析減資之必要性及其效益。
  - (4) 金融商品或資產交易、處理:檢視是否有非常態的金融商品或資產交易買賣,並分 析對公司長期經營的衝擊影響。
  - (5) 企業併購案、(子)公司出售、合資、轉投資:針對公司營運策略、綜效等基本面分析其利弊。
  - (6) 其他:行使歸入權、其他重要章程與作業程序修正等。

本公司指派股東會出席與投票之門檻, 係依金管證投字第 1050015817 號令規定辦理, 僅 在符合下表條件之情形下, 得不指派人員出席股東會行使表決權:

 本公司所經理之任一信託基金持有公開發行公司股份均未達三十萬股,且全部信託基金 合計持有股份未達一百萬股時。



 本公司所經理之任一信託基金持有採行電子投票制度之公開發行公司股份均未達該公司 已發行股份總數萬分之一,且全部信託基金合計持有股份未達萬分之三。

本公司行使投票表決權得依股東會通知書所載,以書面或電子方式為之。採電子投票者應採 電子投票方式行使表決權。

#### 瀚亞投票政策行使原則和指引

積極了解並參與被投資公司的投票,是瀚亞投資股票直投理念的重要組成部份,也是我們積 極擁有權的核心實踐。我們基本支持所投資公司的董事會和管理層。然而,當公司未能達到 我們的合理期待時,我們會考慮透過代理投票來推動變革。通過行使我們的投票權,我們旨 在增加價值並保障客戶的股東權益。

#### > 以原則為基礎

瀚亞投資遵循原則基礎,所有投票權的行使都在我們制定的原則下進行。我們會考量這 些議題,並在必要且投資策略合適的情況下,與公司領導層會面並作出相應投票。若有 可能,我們會在投票前與被投資公司討論任何具有爭議性的議案,以確保我們的目的得 到理解,並確保我們的投票符合客戶的最佳利益。在成本過高且不符合客戶利益的少數 情況下,我們可能會決定不參與代理投票或放棄投票。

### 投票顧問和指引

為了輔助代理投票的決策,我們設有內部流程,並可能會使用代理顧問。我們不會機械 式地採用代理顧問的特定政策和建議,而是會運用我們的判斷,根據我們的指引,依每 項議案的具體情況決定如何投票。

#### 一般說明



董事選舉:

我們會考量代理顧問的建議來評估參選和連任的董事。總的來說,我們會支持信譽良好 的董事,這些董事應具備高質量董事會所需的技能和經驗,並能促進集團的多元化。此 外,董事應獨立於管理層和外部審計。

#### ▶ 高管薪酬:

激勵被投資公司的高管履行職責對投資成效至關重要。一般而言,我們會支持合理的薪酬方案,這些方案應考慮公司的運營市場、業務規模和複雜性,並在短期和長期內與股東回報(包括財務收益)相符。我們鼓勵設立在發生不良行為或不可持續做法時收回款項的規定,以及與公司目標一致的環境和社會成效的激勵措施。我們支持每年對薪酬慣例進行投票。

▶ 其他薪酬:

在不影響董事獨立於執行管理層,並且不會不恰當地鞏固董事在董事會的地位的前提 下,我們可能會支持合理水平的非執行董事薪酬。員工股份計劃通常旨在鼓勵員工表現 得像公司所有者一樣,但也會考量股東權益稀釋的問題。

企業活動:

資本發行、併購、分拆、收購和回購等事件的投票將根據具體情況進行考慮,並根據瀚 亞投資人的最佳利益進行投票。

#### 審計師的任命:

保留高質量的獨立外部審計師是對股東的重要保障。 瀚亞投資可能會支持具有與公司 規模、地理和行業經驗相當,並且能證明獨立於管理層的審計師。

#### 反收購措施:

如果優先購買權和毒藥丸策略等手段不符合少數股東的利益,我們可能會投票反對。

> 股東會議案:

任何空泛解釋的專案,包括"其他事項"或"任何其他事項",都將投票反對。行政



項目,如接受帳目和更改名稱,更改條款或章程,以及所有其他決議,將根據其利弊得 失進行考量,並會考量瀚亞投資人的權益。

我們將至少每年審查一次代理顧問的投票政策和指引,包括其所有的變更。

# 代理研究和代理投票服務

為了協助投票決策,我們設立了內部流程,並在需要時使用代理顧問。自 2022 年起,本公司採用 ISS 國際投票顧問機構 (Proxy Advisor)的服務,以提高投票決策之深度及效率。 ISS 團隊會審查上市櫃公司所發布的股東會議事手冊,根據全球通用的內部政策並結合各地 法規,制定投票建議。如果被投資公司在公司治理、盡職治理、風險管理及受託人義務等有 重大缺失,ISS 會建議反對有關董監事或委員會成員連任。

本公司投資團隊會針對 ISS 建議反對的部份,分析其反對之原因和邏輯,決定是否採用其 建議。代理顧問的投票政策和指引,包含其所有的更動,將定期審視。

代理投票提案可能會導致客戶利益與瀚亞投資及其員工利益之間的衝突。我們將採取明確的 步驟,確保這些步驟最終導向的投票代理決定是基於客戶的最佳利益。


